The Health Insurance Portability and Accessibility Act (HIPAA) mandates that every Covered Entity under the Act follow clearly specified rules and maintain certain facilities for handling Protected Health Information (PHI), approving and tracking PHI disclosures and complaints, and training personnel involved in handling PHI. HIPAA Compliance ePartner™ from Aligned Development Strategies, Inc. (ADSI) is a Web-based application that supports the communication and tracking needs of an organization complying with the HIPAA regulations.

Core modules for Training, Policies and Procedures, Complaints, Disclosures Tracking, Individual Rights and Management Reporting can be customized to meet the specific needs of a HIPAA Covered Entity. This shared repository allows for real-time responses to HIPAA compliance inquiries and the generation of management level metrics and reports.

Training Manager

Document Manager

Reporting

The system provides a collection of standard and management reports for each module.

Security

Secure, user-authenticated access is also provided for the entire system. Additional reports can be created using Crystal Reports and other industry standard report generation tools.
